1.	Development Commissioner of the Special Economic Zone Chairperson ex officio;
2.	Director or Deputy Secretary to the Government of India, Member ex officio; Ministry of Commerce and Industry, Department of Commerce or his nominee not below the rank of Under Secretary to the Government of India
3.	Zonal Joint Director General of Foreign Trade having territorial Member ex officio;

	jurisdiction over the Special Economic Zone	
4.	Commissioner of Customs or Central Excise having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member ex officio;
5.	Commissioner of Income Tax having territorial jurisdiction over the Special Economic Zone or his nominee not below the rank of Joint Commissioner	Member ex officio;
6.	Director (Banking) in the Ministry of Finance, Banking Division, Government of India	Member ex officio;
7.	Two officers, not below the rank of Joint Secretary, to be nominated by the State Government	Member ex officio;
8.	Representative of the Developer of the zone	Special invitee

AND, THEREFORE, the Central Government, in exercise of the powers conferred by sub-section (2) of section 53 of the Special Economic Zones Act, 2005 (28 of 2005), hereby appoints the 22 conferred by sub-section September, 2022 as the date from which the above Special Economic Zone shall be deemed to be Inland Container Depot under section 7 of the Customs Act, 1962 (52 of 1962).
